The Beef Carcase (Classification) (Amendment) Regulations (Northern Ireland) 1994

. 14th December 1994 Made 12th January 1995 Coming into operation

The Department of Agriculture, being a Department designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, acting in exercise of the powers conferred upon it by the said section 2(2) and of every other power enabling it in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Beef Carcase (Classification) (Amendment) Regulations (Northern Ireland) 1994, and shall come into operation on 12th January 1995.
- (2) The Interpretation Act (Northern Ireland) 1954(c) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment of the Beef Carcase (Classification) Regulations (Northern Ireland) 1992

- 2.—(1) The Beef Carcase (Classification) Regulations (Northern Ireland) 1992(d) shall be amended as follows:—
- (2) In regulation 2(1) in the definition of "Commission Regulation" insert ", as amended by Commission Regulation (EEC) No. 2191/93(e)" after "animals".
- (3) In regulation 2(1) the definition of "pistola cut carcase" shall be deleted.
- (4) In regulation 5 all the words from and including "or" to the end of the regulation shall be deleted.
- (5) In regulation 6 all the words from and including "or" to the end of the regulation shall be deleted.
 - (6) Schedule 3 shall be deleted.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

Schedule 3 to and parts of regulations 5 and 6 of the Beef Carcase (Classification) Regulations (Northern Ireland) 1992, S.R. 1992 No. 1 ("the principal Regulations"), were enacted to give effect to the last sentence of Article 1(1) of Commission Regulation (EEC) No. 344/91 (O.J. No. L41, 14.2.91, p. 15) which enabled beef carcases to be stamped on the inside surface. That provision was changed by Commission Regulation (EEC) No. 2191/93 (O.J. No. L196, 5.8.93, p. 17) and all beef carcases are now required to be marked or labelled on the outside surface.

These Regulations amend the principal Regulations to reflect this change and in addition amend the definition of Commission Regulation (EEC) No. 344/91 in the light of the abovementioned change to it.
