The Remuneration of Teachers (Further Education) (Amendment) Order 1984

Made - - - - - 28th December 1984
Coming into Operation 31st December 1984

WHEREAS—

- (1) in pursuance of section 3(1) of the Remuneration of Teachers Act 1965(a) ("the Act") certain matters in respect of which agreement had not been reached in the Committee constituted under section 1 of the Act for the purpose of considering the remuneration payable to teachers paid by local education authorities who are employed in establishments of further education and to other teachers employed by such authorities for the purpose of their functions relating to further education (excluding teachers seconded to bodies which reimburse the employing authorities the amount of their salaries) ("the Committee") were referred to arbitration, and in pursuance of section 4(1) of the Act the recommendations of the arbitrators with respect to those matters have been transmitted to the Secretary of State;
- (2) there is in force an Order made under section 2(4) of the Act with respect to the remuneration of the teachers in question, namely the Remuneration of Teachers (Further Education) Order 1983(b);
- (3) it appears to the Secretary of State that effect can most conveniently be given to the recommendations of the arbitrators by amending the scales and other provisions set out in the document referred to in the said Order, namely the document published by Her Majesty's Stationery Office on 7th October 1983 entitled "Scales of Salaries for Teachers in Further Education, England and Wales 1983"(c) ("the 1983 Document");
- (4) in pursuance of section 2(5) of the Act the Secretary of State has prepared a draft Order setting out the amendments to the 1983 Document which, in his opinion, are requisite for giving effect to the recommendations of the arbitrators; and
- (5) the Secretary of State, as required by section 2(6) of the Act, has consulted the Committee with respect to the draft Order and the Committee have made no representations with respect thereto:

Now, therefore, the Secretary of State, in pursuance of sections 2(6) and 7(3) of the Act, hereby makes the following Order, which is in the form of the draft:—

- 1.—(1) This Order may be cited as the Remuneration of Teachers (Further Education) (Amendment) Order 1984.
- (2) This Order shall come into operation on 31st December 1984 and shall have effect as from 1st April 1984.
- 2. The Scales and other provisions contained in the 1983 Document are hereby amended, with effect from 1st April 1984, in the manner specified in the Schedule to this Order.

SCHEDULE

AMENDMENTS EFFECTIVE FROM 1ST APRIL 1984

- 1. In section 13-
 - (a) in sub-section (1) for the sum of £444 there shall be substituted the sum of £465 and for the date 1 April 1983 there shall be substituted the date 1 April 1984.
 - (b) in sub-section (2) for the sum of £1266 there shall be substituted the sum of £1323 and for the words "Individual allowances payable on 31 March 1983 shall be increased by 4.5 per cent, rounded to the nearest multiple of £3, from 1 April 1983" shall be substituted the words "Individual allowances payable on 31 March 1984 shall be increased by 4.6 per cent, rounded to the nearest multiple of £3, from 1 April 1984.";
 - (c) in sub-section (3) for the sums of £1278 and £1953 there shall be substituted the sums of £1338 and £2043 respectively and for the words "Individual allowances payable on 31 March 1983 shall be increased by 4.5 per cent, rounded to the nearest multiple of £3, from 1 April 1983." shall be substituted the words "Individual allowances payable on 31 March 1984 shall be increased by 4.6 per cent, rounded to the nearest multiple of £3, from 1 April 1984.";
 - (d) in sub-section (4) for the sums of £1125 and £894 there shall be substituted the sums of £1176 and £936 respectively, and for the words "Individual allowances payable on 31 March 1983 shall be increased by 4.5 per cent, rounded to the nearest multiple of £3, from 1 April 1983." there shall be substituted the words "Individual allowances payable on 31 March 1984 shall be increased by 4.6 per cent, rounded to the nearest multiple of £3, from 1 April 1984."

4. In Appendix III-

- (a) For paragraph 6 there shall be substituted the following paragraph—
- "6. (1) In paragraphs 9, 13A, 13B, 14, 15 and 18 of this Appendix incremental credit to be calculated in accordance with this paragraph shall be calculated as follows:—
 - (a) Where the point payable on the relevant former scale is below the minimum point on the relevant new scale, $1\frac{1}{2}$ times the difference between that minimum point and the next point above rounded up in accordance with sub-paragraph (2).
 - (b) Where the point payable on the relevant former scale coincides with a point on the relevant new scale, $1\frac{1}{2}$ times the difference between that latter point and the next point above rounded up in accordance with sub-paragraph (2).
 - (c) Where the point payable on the relevant former scale falls between two points on the relevant new scale, $1\frac{1}{2}$ times the difference between those two points rounded up in accordance with sub-paragraph (2).

- (2) Incremental credit in all calculations under this paragraph or under paragraphs 7 to 17 inclusive and 19(b) of this Appendix shall unless they result in an exact incremental point, be rounded up to the minimum incremental point or to the next higher incremental point on the appropriate scale.".
- (b) In paragraph 9(2) there shall be substituted for the words "equal to 1½ increments on the Lecturer Grade I or Grade IA scale" the words "by way of incremental credit calculated in accordance with paragraph 6 of this Appendix".
- (c) In paragraph 13A(4) for the words "equal to $1\frac{1}{2}$ increments on the new scale," there shall be substituted the words "by way of incremental credit calculated in accordance with paragraph 6 of this Appendix,".
- (d) In paragraph 13B(1) for the sum of £217 shall be substituted the sum of £227.
- (e) In paragraph 13B(2) for the words "equal to $1\frac{1}{2}$ increments on the new scale" the words "by way of incremental credit calculated in accordance with paragraph 6 of this Appendix".
- (f) For paragraph 14 there shall be substituted the following paragraph:—
 "14. A Senior Lecturer appointed in that capacity on or after 1 April 1984 shall enter the appropriate scale—
 - (1) either
 - (a) at the minimum to which shall be added incremental credit up to and including point 4 in respect of time spent as a Senior Lecturer to whom the Further Education Salaries Documents under the Remuneration of Teachers Act 1965(a) or a Pelham Report applied, or in other educational service or commercial, professional or research work which in the opinion of the local education authority should be regarded as equivalent to service as a Senior Lecturer, or
 - (b) where the Senior Lecturer is appointed after teaching service to which this document or the corresponding document relating to teachers at maintained schools(b) applies, at the salary payable in the former post (excluding any "London Area" allowance) plus (except where the salary scale applicable to his former post had the same or a higher maximum) an additional sum by way of incremental credit calculated in accordance with paragraph 6 of this Appendix but so that no such addition shall cause his salary to exceed point 4 on the scale

whichever, except where sub-paragraph (3) below applies, is the higher.

(2) Except where sub-paragraph (3) below applies, where the Senior Lecturer is appointed after service other than teaching service to which this document or the corresponding document relating to teachers at maintained schools applies, and the salary calculated under sub-paragraph (1)(a) above is considered by the local education authority to be inadequate, at such point up to and including point 4, as the local education authority deem appropriate having regard to the entitlement of former teachers under sub-paragraph (1)(b) above.

- (3) Where the salary corresponding to point 4 on the Senior Lecturer scale is less than the teacher's former salary (excluding any "London Area" allowance) in the post he held immediately before appointment and he is entitled, under the provisions of Appendix IA of this document to proceed beyond point 4 of the Senior Lecturer scale, at such incremental point above the said former salary as the local education authority deem appropriate.".
- (g) For paragraph 15 there shall be substituted the following paragraph:—
 "15. A Principal Lecturer appointed in that capacity on or after 1 April 1984 shall enter the appropriate scale—
 - (1) either
 - (a) at the minimum to which shall be added incremental credit up to and including point 3 in respect of time spent as a Principal Lecturer to whom the Further Education Salaries Documents under the Remuneration of Teachers Act or a Pelham Report applied, or in other educational service or commercial, professional or research work which in the opinion of the local education authority should be regarded as equivalent to service as a Principal Lecturer, or
 - (b) where the Principal Lecturer is appointed after teaching service to which this document or the corresponding document relating to teachers at maintained schools applies, at the salary payable in the former post (excluding any "London Area" allowance) plus (except where the salary scale applicable to his former post had the same or a higher maximum) an additional sum by way of incremental credit calculated in accordance with paragraph 6 of this Appendix but so that no such addition shall cause his salary to exceed point 3 on the scale

whichever, except where sub-paragraph (3) below applies, is the higher.

- (2) Except where sub-paragraph (3) below applies, where the Principal Lecturer is appointed after service other than teaching service to which this document or the corresponding document relating to teachers at maintained schools applies, and the salary calculated under sub-paragraph (1)(a) above is considered by the local education authority to be inadequate, at such point up to and including point 3 as the local education authority deem appropriate having regard to the entitlement of former teachers under sub-paragraph (1)(b) above.
- (3) Where the salary corresponding to point 3 on the Principal Lecturer scale is less than the teacher's former salary (excluding any "London Area" allowance) in the post he held immediately before appointment and he is entitled, under the provisions of Appendix IA of this document to proceed beyond point 3 of the Principal Lecturer scale, at such incremental point above the said former salary as the local education authority deem appropriate.".
- (h) In paragraph 18(2) for the words "equivalent to $1\frac{1}{2}$ increments on the appropriate Head of Department scale" shall be substituted the words "by way of incremental credit calculated in accordance with paragraph 6 of this Appendix".

- 5. In Appendix III Annex B—
 - (a) For paragraph 1 thereof there shall be substituted the following paragraph:— "1.(i) A course leading to the degree of Bachelor of Education, the Certificate in Education, the Post-graduate Certificate in Education or a comparable academic award of a university in the United Kingdom or of some other institution and validated by the Council for National Academic Awards provided that such course is approved as a course for the initial training of teachers in schools by the Secretary of State for Education and Science for the purposes of paragraph 2(a) of Schedule 5 to the Education (Teachers) Regulations 1982(a).
 - (ii) A course leading to a Certificate of Education (Further Education) validated by the Council for National Academic Awards".
 - (b) Paragraphs 5 and 6 shall be deleted.
- 6. In Appendix IV for the sums £12.15, £10.63 and £7.58 there shall be substituted the sums of £12.70, £11.12 and £7.96 respectively.
- 7. In Appendix V, paragraph 2, for the words "Where a Lecturer Grade I, Lecturer Grade II, Senior Lecturer or Principal Lecturer employed in teaching on a course of teacher training is seconded to a school for the purpose of research or of refreshing his experience of school teaching or is seconded to any other occupation approved by the seconding authority," there shall be substituted the words "Where, for the purposes of their functions relating to further education, a local education authority seconds a Lecturer Grade I, Lecturer Grade II, Senior Lecturer or Principal Lecturer employed in teaching on a course of teacher training to a school or to any other occupation".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends with effect from 1st April 1984, provisions contained in the document setting out the scales and other provisions for determining the remuneration of teachers employed in further education establishments who are paid by local education authorities and of other further education teachers employed by such authorities. This document, entitled "Scales of Salaries for Teachers in Establishments for Further Education, England and Wales 1983" may be obtained from Government Bookshops or through booksellers. The Order gives effect to the recommendations of the arbitrators appointed under section 3 of the Remuneration of Teachers Act 1965. The restrospective effect of the Order is authorised by section 7(3) of that Act.
