# LOCAL GOVERNMENT, ENGLAND

### The Derbyshire Dales (Electoral Changes) Order 2024

Made - - - - 2nd April 2024

Coming into force in accordance with article 1(2) and (3)

Under section 92(2) of the Local Government and Public Involvement in Health Act  $2007(\mathbf{a})$ , Derbyshire Dales District Council ("the Council") made a recommendation in a review to the Local Government Boundary Commission for England(**b**) for the related alteration of the boundary between two district wards within the Council's area.

The Local Government Boundary Commission for England has decided to give effect to the recommendation and makes the following Order in exercise of the power conferred by section 92(3) of that Act.

#### Citation, commencement, extent and application

1.—(1) This Order may be cited as the Derbyshire Dales (Electoral Changes) Order 2024.

- (2) This article comes into force on the day after the day on which this Order is made.
- (3) Article 2 comes into force—
  - (a) for the purpose of proceedings preliminary or relating to the election of councillors, on the day after the day on which this Order is made;
  - (b) for all other purposes, on the ordinary day of election of councillors in England(c) in 2027.
- (4) This Order extends to England and Wales but applies in relation to England only.

#### Alteration of a district ward boundary

**2.** Following the alteration of the boundary between the parish of South Darley and the parish of Matlock by virtue of the Derbyshire Dales District Council (Reorganisation of Community Governance) Order 2022(d), the parish ward of Oker and Snitterton in the parish of South Darley

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order gives effect to a recommendation made by Derbyshire Dales District Council ("the Council") to the Local Government Boundary Commission for England for the related alteration to the boundary between two district wards within the Council's area.

The alteration is a consequence of changes to parish boundaries and warding arrangements under the Derbyshire Dales District Council (Reorganisation of Community Governance) Order 2022, which was made by the Council under powers including section 86 of the Local Government and Public Involvement in Health Act 2007 (c. 28). Such orders are not required to be made by statutory instrument. The change described in article 2 (in relation to district wards) applies in respect of elections to be held on and after the ordinary day of election of councillors in England in 2027.
